Dear Ms. Moskowitz -- This is not a "done deal" and I believe I said so at the meeting. The Library Board has its views on how the project should proceed and is advocating for them as they are entitled to do. However, the Village Board is still in the process of considering the matter and has some more thinking to do before a conclusion is reached.

It is the case that the Village is budgeting so it may finish the largely empty second floor space at the Supply Field building. It is doing so in part because if the Library renovation goes ahead, the Supply Field could house the temporary Library. However, that space has been looked for several years at as a place the Village might allocate for a variety of Village uses such as moving the Parks and Recreation Department offices there to free up space in Village Hall as one example. So the Supply Field building interior finishing project that was talked about might get done -- although even that is not a certainty.

As for the Library renovation itself, the Village Board still has a lot of thinking to do before it reaches a conclusion on whether or not to proceed with that proposal or some version of it. It is the intention to have further public meetings on this topic as more facts and information are gathered, and before concluding on the matter.
