

Hi Stephen and Mayor,

I am Kevin's dad. Thank you so much for your clarifications. Based on my observation, the traffic on Madison Rd is much heavier than Sprague Rd. When we moved to Scarsdale three years ago, there is no stop sign on Lotus Ave but there is a stop sign on Madison Rd. Last year, a stop sign was installed on Lotus Ave. So now, on Madison's intersection with Blvd and Lotus, it is four-way stop sign. Eastchester Village realized the need to install a stop sign on Lotus Ave. They did the right thing. Even Blvd has a stop sign at its intersection with Madison. I do not understand why we cannot install a stop sign on Sprague Rd at its intersection with Madison. My two boys and a few other students from Madison start to walk to school sometimes, but I am very concerned about their safety when crossing the Sprague. Every year, we saw car accidents in the intersection between Sprague and Madison. Please seriously consider to install a stop sign on Sprague Rd. Thank you for your attention to our children's safety concerns.

Mr. Han,

Thank you for your email and concern for traffic safety in the Arthur Manor neighborhood. Please be advised that Sprague Road is classified as a "collector" road in our highway classification system, intended to move traffic from residential streets to arterial roadways, while providing access to residences throughout the Village. As such, traffic volumes are heavier, requiring traffic to move quicker on Sprague than the intersection streets such as Madison. The intersecting streets are classified as "residential" and all have stop signs yielding traffic to the collector road, Sprague in this case, which is a provision in the Federal Highway Manual for traffic safety guidelines at these "T" intersections. There are exceptions whereby stop signs currently exist on Sprague, specifically at Clarence and Nelson Roads. The Village employs a Traffic Safety Committee to investigate suggestions from residents for regulatory signs and I will ask that they review your request. They will review exiting data for accidents, traffic volumes and visibility at the intersection of Sprague and Madison. Once the Committee has reviewed we will reply with a formal determination.
