Dear Mayor,

My name is Jason Winkler, and I have been a resident of Garth Road for five plus years. I am also a pediatrician in the local community. My wife and I are writing this letter to inform you of a problem with one of the intersections in the Village of Scarsdale, namely the intersection of Garth Road and Popham Road. My wife and I are avid walkers, especially now that we have a 3 month old baby, and a troublesome event happened this past weekend. While crossing Popham Road from Garth Road (east corner of the street), we were nearly hit by not one, but two cars,

who were speeding around the corner, turning a sharp right from Garth Road onto Popham Road - these drivers were clearly not keeping an eye out for pedestrians. What made it more worrisome is that we were pushing our baby in the stroller! This is not the first time this has happened - I would say that this is the third or fourth time that we felt we were almost hit while crossing the intersection. My wife and I cross only when the light directs us so it is not like we are crossing at times when we are not supposed to. My wife and I have also seen others cross who almost get hit, and have frequently seen pedestrians stop short and quickly raise their arms up in disbelief over the cars nearly hitting them through the intersection.

My wife is so distraught over this that she now refuses to cross the intersection, instead preferring to walk along the Bronx River Pathway from Harney Road to Scarsdale train station so she does not have to cross the intersection.

My suggestion is to have a "No Turn on Red" sign on the Garth Road part of the intersection as well as a pedestrian crossing only part of the traffic light cycle (i.e., a part of the traffic light cycle where everyone has a red light except for pedestrians).

I am very concerned that a pedestrian will be struck by a motorist at some point on this intersection.
