Food Composting Does Not Make Cents

While saving the earth is a great idea, food composting by Scarsdale does not make Cents. The cost is outrageous. \$45,000.00 for a limited trial is extremely expensive and multiplied by ten times for a full program is out of sight. That amount is \$450,000.00. We are under a budget cap of .12% this year. The money that people are asking to be spent on food composting can be used to pave a mile of roads in the village. Try walking on our streets and you will see that they need repaving more than recycling a few scraps of food. We compost food in our bin in our back yard. If people want to compost food they can bloody well buy their own compost bin like we have done and compost food themselves.

Let another town take the lead and let us wait for the cost to be reduced when there is a recycling plant in Westchester that will take the food at a reasonable cost.

I and many senior citizens are on a fixed budget. This is a cost we do not want or need to add. We are the highest taxed county in the country. Governor Cuomo is correct in requiring our municipalities to watch our budgets. The library needs expanding. The schools need to be fixed. All this costs money and many of our senior citizens are being taxed out of town.

Perhaps Mr. Stern is much richer than I am and thinks money grows on trees. My son gave me a mug stating that when he was much younger. He now knows that is not true. Perhaps Mr. Stern should be given a mug that states money does not grow on trees. He is a trustee and is supposed to look after the wellbeing of the finances of our town by keeping expenses and taxes down. We are the most taxed county in the U.S. His job is to look after the expenses of our town and keep them in check. I applaud Mayor Mark for dong that and knowing that we cannot keep spending on frivolous items. Mr. Finger should also take a lesson from our mayor. It would be cheaper for the town to buy every household a recycling bin than to put this program in place.
