Mark -- Thanks. I took a look at the article. Among other things, it mentions that part of what the Mount Vernon schools is planning involves the change over to LED lighting in the schools. As you know, the Village has done an initial trial of a limited number of LED street lights and is now set to embark on a second level pilot program to test the use of LED lights on high-traffic streets and "Town & Country" style post-top street lights that are located in certain parts of the Village. Depending on the results of that test, including resident feedback on the the LED lights, the Village would then consider rolling out LED street lights on all high-traffic streets and "Town & Country" style post-top street lights. Further, LED street light installation throughout the Village would be considered depending on how that roll-out worked, including residents' reaction to it. One reason the change to LED street lights would be made would be anticipated energy cost savings. I commented on this project, and the fine work done by the resident Ad Hoc Committee the Board appointed to spearhead this effort, at some length at our January 26, 2016 BOT meeting. In terms of other Village buildings -- Village Hall, the fire stations, the buildings at the recycling center and the Library -- the Village staff can give us their input on whether any such program might be cost effective and desirable. (Since the Public Safety Building was recently renovated, it would not be on this list.) It is noted that there is already a plan to do renovations at Fire Station number one (next to Village Hall) that is in final design stages and of course the Library has proposed a significant renovation of its building. Both of these plans would have some of the energy-saving features mentioned in the Mount Vernon plan.

In terms of the schools considering a project similar to Mt Vernon's, I leave that to Scott and his colleagues to comment on.
