Mayra,

The meeting will be recored and available online and there will be a 45-day public comment period to provide ample time for community input. There will be time at the meeting for the community to provide comments on its preferences and priorities as well as questions on the process and, given the conceptual nature of the development proposals, mainly clarifying questions about the developers' presentations.

Keep in mind that this specific segment of the Freightway process is designed to select a preferred developer with which to enter into a public-private partnership - similar to the successful process used to develop Christie Place.

Once a preferred developer is selected, the developer will begin to spend material resources on site diligence and other items, including more refined programatic details and architecture and engineering. The results of the site diligence will yield an iterative process whereby the preferred developer presents a development plan to propose to the community for its consideration. Included in submissions of the development plan will be extensive analysis of impacts including fiscal, school, parking, traffic, environmental, and more.

The Village looks forward to your continued involvement throughout the Freightway process.

Thank you for your email, Mayra, and we hope you had a nice Thanksgiving holiday.

As we have mentioned to you previously, your Freightway questions are relevant and will be addressed in detail over time as the land use process progresses. In the meantime, the Village Board is acting in its fiduciary capacity to maximize the value of this important Village-owned asset. While the Board is committed to an inclusive public process, public disclosure of financial information could impede the Village's negotiating position with the two finalists and therefore impact the value of the Freightway property. Like you, we are focused on the detailed responses to your questions and we look forward to the process moving forward to the point at which these items will be addressed in a public forum.

The Village is seeking to select a designated developer with which to move forward with a public-private partnership to redevelop the Freightway site - in similar fashion to the successful public-private partnership that was used to develop Christie Place and provide the Village with substantial parking capacity for Village residents. We have been informed by Village consultants that re-opening the RFP process to the entire development community would be a show of bad faith that may cause some of the parties that responded to the RFEI to withdraw from the process. Since the RFEI was widely distributed to the regional development community, it was determined that the risks of widely distributing the RFP outweighed the potential benefits, and, accordingly, the Village Board decided to follow the strong advice of its consultants and issue to those RFEI respondents that submitted proposals that met the primary objectives of the RFEI, including the visioning study.

As the Village Board has mentioned on a number of occasions, we are seeking a development proposal that provides the community with a net fiscal benefit. Like you, we are residents that are seeking to enhance the vibrancy of the Village Center, including the primary Village commuter parking facility, while being fiscally responsible to existing taxpayers.

As you are aware, there is a community meeting scheduled on December 11th at 7pm in Rutherford Hall. We hope you are able to attend the meeting. If you are not available, the meeting will be taped and available for replay at your convenience and the public comment period will be open until January 23, 2020.

With regard to your other comments related to financial and strategic planning, we invite you to attend the Village Board meetings and work sessions that deal with the Village budget. These

meetings address, among other things, long-term strategic and financial planning.
