## Bob,

Attached please find the Village Board resolution approving the Recreation Fees and Charges Schedule for FY 2018/19. The resolution was approved unanimously by the Village Board at their February 13, 2018 meeting. This approval was subsequent to a lengthy discussion on the proposed fee changes at the Board's publically noticed and open Finance Committee meeting on January 18, 2018. Also attached are the applicable pages from the supporting memorandum for all recommended fee changes to the tennis program. Finally the applicable page from the adopted Fees and Charges Schedule identifying the year-to-year increase in the Youth Tennis Permit is attached.

Unfortunately, the Recreation Department's spring/summer brochure lists the FY2017/18 Junior Tennis Permit fee of \$65.00 as opposed to the FY2018/19 fee of \$75.00. As the majority of residents register and pay for Recreation Dept. programs on-line, and our website lists the correct fee of \$75.00, we have not had an issue with the misprint in the brochure. The Recreation Superintendent also reports that he has yet to receive complaints about the \$10.00 increase and enrollment is about where it was last year, in spite of the recent March storms impacting and disrupting the residents at the tail end of winter. The \$65 fee identified in the brochure is unfortunate, however there has been no expressed concerns at this point, other than your email. Please feel free to refer the concerned residents to Brian who will be happy to discuss the fee increase with them.
